In exercise of the powers conferred by sub-section (4) of section 7-C of the Odisha Education Act, 1969 (Odisha Act 15 of 1969), the State Government do hereby make the following Order further to amend the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order, 2008 to regulate the payment of Grant-in-Aid in shape of Block Grant, namely:-

1. **Short title and commencement** - (1) This Order may be called the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-Aid (Amendment) Order, 2023.


(2) It shall apply to the aided Non-Government Colleges, Aided Junior Colleges and Aided Higher Secondary Schools.

2. In the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order, 2008, the following provision shall be inserted as para 6 after para 5 of Annexure-II.

“6. (i) One post of Library Attendant in Non-Government College, Junior College and Higher Secondary School is eligible to receive Block Grant where the number of admissible student strength is more than 350.

(ii) Payment of Block Grant under this Order shall be made w.e.f. the 20<sup>th</sup> January, 2009 which is the date of publication of the Odisha (Non-Government Colleges, Junior Colleges and Higher Secondary Schools) Grant-in-aid Order, 2008 in the Extra-ordinary issue of the Odisha Gazette.”
