Applications in the prescribed format (Copy enclosed) are invited from the eligible desirous retired Government Engineers having sufficient experience in the construction of buildings as Assistant Executive Engineer (Civil) or above rank, having a maximum age up to 65 (sixty-five) years having good service records and physically fit for **engagement 02 (two) nos. of Engineering Consultant** for verification and scrutiny of plan and estimates, supervision of works, enquiry of complaints received from HEIs and preparation of SOP for infrastructure development and any other work assigned by the Department on a contractual basis in SAMS Society functioning at Higher Education Department functioning at Loka Seva Bhavan and HoD building in pursuance of Finance Department Office Memorandum No. 24533/F, dated 29.09.2022

The contractual engagement shall be made initially for a period of 01 (one) year. The period of engagement may be extended subject to satisfactory performance not beyond the age of 65

1. The retired employees against whom a Vigilance Case or any Disciplinary Proceeding or Criminal Prosecution is contemplated or pending or who have been penalized for misconduct during the period of 5 years preceding his/her retirement or is a member of a political party will not be considered for re-engagement.
2. Retired employees having relevant experience in respect of work will be given preference.
3. The consolidated remuneration of the engaged retired employees shall be fixed as per Finance Department O.M. No. 24533/F, dated 29.09.2022.
4. The re-engaged Engineering Consultant has to discharge such duties and in such a manner, as may be prescribed by Higher Education Department from time to time.
5. The period of contractual engagement shall not be counted as Government service for the purpose of pension and any other retirement benefits.
6. The Engineering Consultant shall be subject to and abide by the prescribed Conduct Rules (Odisha Government Servants' Conduct Rules, 1959) applicable to the Government servant and liable to be proceeded against for

their misconduct, omissions and commissions as per the provisions under Odisha Civil Services (Pension) Rules, 1992.

9. The contractual engagement may be terminated at any time by the Competent Authority due to unsatisfactory performance by giving one month's notice and in case of any misconduct including, but not limited to, misappropriation, negligence or causing loss to the Government, without prior notice. In case the re-engaged officer desires to resign from the engagement, she/ he shall do so by giving one month's notice in writing to the Competent Authority.
10. The applicant shall furnish an Undertaking at the time of joining the duty in regard to the truth and correctness of the information furnished by her/ him. She/he shall have to furnish prescribed undertakings and such other documents as may be required.


