Applications invited from (eligible) interested Law Graduates/ Law Students (continuing course) for undergoing a short-term Legal Training Programme to be imparted by SAMS Society, Higher Education Department

Student Academic Management System (SAMS) Society a society registered under the Societies Registration Act, 1860 intends to facilitate fresh Law Graduates imparting short-term legal training on a stipend basis for a duration of 06 months in the Higher Education Department.

SAMS Society is intended to facilitate freshers for the Legal Training Program for a duration of 06 months for the year 2023-2024 from law students of a Graduation course and enrolled in a reputed Law University/Institute of Odisha or applicants who have passed LLB not before 2020.

- ➤ A maximum of 06 (4+2) persons will be selected for the training through a selection process to be conducted by SAMS.
- > The duration of the training programme is 06 months
- ➤ Each trainee will get a stipend of Rs. 10,000/- per month, to be paid by SAMS Society

**Educational Qualifications:** - In order to be eligible for selection, a candidate must possess the following education qualification:

➤ For Law Graduates, he or she must have passed a minimum LL.B. degree from any recognized University not before 2020 and must have been recognized by AICTE/UGC.

For Law Students who are pursuing a 03-year LL.B. course, he or she must have completed the 4th semester course.

➤ For Law Students who are pursuing a 5-year integrated Law course, he or she must have completed the 8<sup>th</sup> semester course.

## **Eligibility Criteria:**

Only Indian National candidates are eligible to apply for the training.

- ✓ SAMS Society has no obligation to give regular employment to Trainees. Such training does not confer any rights on the trainee to obtain regular employment at any point of time. This training program shall not create any liability on SAMS Society for providing any job to the Trainee. SAMS Society does not take any responsibility for any sort of employment/placement.

  to eligibility, acceptance or rejection of the applications, mode of selection, cancellation
