Applications are invited from eligible candidates (academicians of repute with adequate administrative experience) below 62 years of age (as on 31st January 2024, i.e. born after 31.01.1962) for the position of Vice-Chancellor of Odisha State Open University, Sambalpur, Odisha. The applicant should be a distinguished academician of proven academic and administrative excellence and a well-rounded personality with a minimum of 10 years of experience as Professor in a University or 10 years in an equivalent position in reputed research and/ or academic organization.

The post carries a pay of Rs. 2,10,000/- (Rupees two lakhs and ten thousand) only with Special Allowance of Rs. 11,250/- per month and other usual allowances. The tenure of the Vice-Chancellor will be three years from the date he/she assumes office or till he/she attains 65 years of age; whichever is earlier.
