APPOINTMENT ORDER

No.HE-GCET-MISC-0112-2022/ 43372 /HE., In pursuance of orders of Hon'ble High Court dated 20.09.2022 passed in W.P.(C) No.13681 of 2022 , Siba Prasad Panda – Vrs.- State of Odisha and others and in supersession of this Department Office Order No. 26837/HE., dated 29.06.2022, the following candidates are hereby appointed as Assistant Professor (Teacher Education) in **Geography** in Odisha Education Service (College Branch) cadre, which is a Group-A service under the Higher Education Department of the State Government. They will be entitled for an initial pay of Rs. 57,700/- in Level-10 (Cell 1) of pay matrix under Odisha Revised Scale of Pay (College Teachers) Rules, 2019 and allowances admissible from time to time from the date they actually join the service.

2. The candidates shall attend a 5-day Induction Training programme, starting from 17.10.2022 (9.00 A.M) in Utkal University, Bhubaneswar and will, thereafter, be posted to a Government Teacher Education College/ Government Degree College.

3. On the first date of the Induction Training, option for place of posting shall be obtained from all candidates. On the last date of the Induction Training, Government order will be issued posting them to the different Government Teacher Education Colleges/Government Degree College, as per GA & PG Department Resolution No. 14327/GEN dated 04.07.2017. They shall report to the Principal of the Government Teacher Education College/ Government Degree College concerned soon after the Induction Training.

4. Their appointment and other service conditions shall be governed by Odisha Education Service (College Branch) Recruitment Rules, 2020 and other State Government rules as applicable.

5. Each candidate shall have to submit following documents at the time of joining.

- i) Medical Certificate in support of physical fitness from CDM & PHO/CMO/ Medical officer of equivalent rank.
- ii) Undertaking that she/he has only one spouse living, in case she/he is married.

6. This appointment order shall remain valid normally for one month from the date of issue of this Notification and shall stand cancelled automatically if the candidate fails to join on or before the stipulated date.






