





### Timeline for e-Admission into 3 Year LLB Course under SAMS in the Higher Education Institutions for the Academic Session 2024-25

It is for information of all concerned that admission into 3 years L.L.B Courses at the below mentioned HEIs has been newly included under SAMS for the Academic Session: 2024-25. Accordingly, the candidates are hereby instructed to fill-up the Common Application Form by visiting the SAMS portal as per the timeline mentioned below. The Common Prospectus (CP) for the said courses are available on the SAMS portal. Please refer to the Common Prospectus before filling up the CAF. The key points for admission into 3 years L.L.B Courses for the current Academic Year 2024-25 are as follows.

1. The Following HEIs have been included under SAMS for admission into 3 years LLB Courses for the Academic Session: 2024-25.
  - a) Madhusudan Law University, Cuttack - 120 seats
  - b) University Law College, Utkal University, Bhubaneswar - 60 seats
  - c) Lingaraj Law College, Berhampur -180 seats
2. The applicants who have successfully passed the +3 examination (Any stream) or any other equivalent Examination from a recognized University in India shall be eligible for admission into 3 Year LL.B. Course. Applicants can choose minimum one (1) and maximum three (3) nos. of HEIs as per his/her preference.
3. Provisional allotment of seats will be prepared through centralized selection process on the basis of the marks & reservation details provided in the CAF. No Entrance Examination will be held for admission into the said course.
