Applications invited from (eligible) interested Law Graduates/ Law Students (continuing course) for undergoing a short-term Legal Training Programme to be imparted by SAMS Society, Higher Education Department

Student Academic Management System (SAMS) Society a society registered under the Societies Registration Act, 1860 intends to facilitate Law Graduates imparting short-term legal training on a stipend basis for a duration of 01 year in the Higher Education Department.

For the year 2024-25 SAMS Society intends to facilitate the Legal Training Program for a duration of one year to Law graduates (passed out not before 2021) and Law Students continuing in the final year of Graduation course enrolled in a reputed Law University/Institute of Odisha.

- A maximum of 20 individuals will be selected through an online examination followed by interviews conducted by the SAMS Selection Committee.
- The duration of the training programme is One Year
- Each trainee will get a stipend of Rs. 10,000/- per month to be paid from SAMS Society.

Educational Qualifications: - In order to be eligible for selection, a candidate must possess the following education qualification:

- For Law Graduates, he or she must have passed a minimum LL.B. degree from any recognized University not before 2021 and must have been recognized by AITE/UGC.
- For Law Students who are pursuing a 03-year LL.B. course, he or she must have completed 4th semester course.
- For Law Students who are pursuing a 5-year integrated Law course, he or she must have completed the 8th semester course.

Eligibility Criteria:

- Only Indian National candidates enrolled in a reputed Law University/Institute of Odisha are eligible to apply for the training.

1. How to Apply

- a. The candidate has to apply online through the link provided.
- b. The candidate must provide their valid mobile E-mail ID/Mobile No for all types of correspondence/communication.

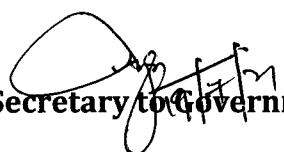
2. Selection Procedure:

- a. Eligible candidates will undergo an online examination.
- b. Shortlisted candidates will be invited for an interview, and final selections will be based on interview performance.
- c. Original certificates will be verified during the interview.

4. General Details:

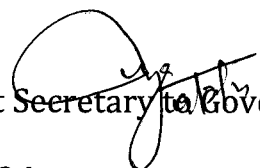
- Applicants, who fulfil all the above conditions, can only apply.
- The date and time of the online exam will be intimated to applicants through e-mail ID only.
- The candidates will be called for an interview through their e-mail ID. The final selection will be based on the candidate's interview marks. All original certificates will be verified during the time of the interview.
- The number of candidates to be engaged is indicative and may undergo changes without any further notification.
- SAMS Society has no obligation to give regular employment to Trainees. Such training does not confer any rights on the trainee to obtain regular employment at any point of time. This training program shall not create any liability on SAMS Society for providing any job to the Trainee. SAMS Society does not take any responsibility for any sort of employment/placement.
- The decision of the Society is final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of the applications, mode of selection, cancellation of the selection process either in part or full, etc. No correspondence will be entertained in this regard.
