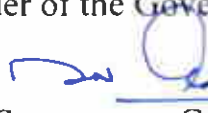
No. HE-PR-POLICY-0001-2023 **45756** /HE., Bhubaneswar, Dated **14/11/2024**

In pursuance of the decision taken by the High Power Committee under the Higher Education Department in its meeting held on 12.07.2024, the Government after careful consideration have been pleased to declare that whenever any Educational Agency or Governing Body of Non-Government college/Institution, after getting permission from the Government for establishment of a college/institute, fails to run the college/institute as per the provisions of OE Act, 1969 or rules or guidelines made there under and the college/Institution or the Prescribed Authority after following due procedures proposes for its closure and the Government accords necessary permission for the closure, 25% of the total pledge money of the concerned college/institution as prescribed while granting opening permission shall be forfeited with immediate effect.

The said amount shall be deposited under the Head of Account -"**0202-Education, Sports, Art and Culture-800- Other Receipts- 0097- Misc. Receipts - 02082-Miscellaneous other Receipts**".

This order supersedes the earlier Office Order No. 33450/HE, dated 07.12.2017.
