CORRIGENDUM NOTICE

In continuance with Pre-Bid meeting held on 05.12.2024 for Tender Notice No. 34/SIEP, Dated 25.11.2024 on selection of service provider agency for housekeeping, upkeep & maintenance, security & catering for Manodaya(SIEP), following modifications/additions is hereby issued in the Tender Bid documents:

1. The rate of wages as mentioned at Form-F1: Price Bid Format-Section-A (Page no.-70) is amended in accordance with Notification No. 6432/LC, dated 30.09.2024 of Labour Commissioner, Odisha in following manner:

Unskilled: Rs. 452/- per day

Semi-skilled: Rs. 502/- per day

Skilled: Rs. 552/- per day

The wage rates as prescribed from time to time by Labour Commissioner, Odisha will be applicable to persons engaged through above tender.

2. Section-I: Eligibility Criteria- Point 5 (Page No.-6), "Must have atleast Rs. 5.00 Cr. Annual Financial Turnover in each during the last 5 financial year of (2019-20, 2020-21, 2021-22, 2022-23, 2023-24)" should be read as "Must have Average Annual Financial Turnover of Rs. 5.00 Cr. during the last 5 financial year of (2019-20, 2020-21, 2021-22, 2022-23, 2023-24)"
3. Section-I: Eligibility Criteria- Point 6 (Page No.-6), "Must have its own bank account in any scheduled bank situated in Bhubaneswar" is replaced as "Must have its own bank account in any scheduled bank situated in Odisha".
4. Section-I: Eligibility Criteria- Point 9 (Page No.-7) - Bidders are required to submit undertaking that they shall submit Food License under FSSAI (Food Safety and Standards Authority of India) at the time of signing of Contract Agreement.
