### **Timeline for SPOT-II Admission into U.G., P.G., 2 years B.Ed./ M.Ed., 3 years LL.B. & 3 years Integrated B.Ed.-M.Ed. Courses in the Higher Education Institutions participating under SAMS for the Academic Session: 2024-25**

- This is to inform all concerned that admission to the remaining vacant seats in U.G., P.G., 2 years B.Ed. /M.Ed., 3 years LL.B. & 3 years Integrated B.Ed.-M.Ed. courses at the Higher Education Institutions participating under SAMS will be conducted through a SPOT-II admission process.
- The eligibility for the aforementioned courses are mentioned in the Common Prospectus available on the SAMS portal.
- In this SPOT-II admission process for admission into P.G. & 2 years B.Ed. /M.Ed. Courses, applicants must have appeared in the CPET-2024 & Teacher Education Entrance Examination respectively and must have obtained a rank.
- In the SPOT-II admission process, both admitted and non-admitted students are eligible to participate for all the aforementioned courses.
- If an applicant has taken admission in any of the HEIs in earlier Phase(s)/Round and got selected in this SPOT-II admission round, s/he has to obtain the CLC physically from the last admitted HEI within 7<sup>th</sup> Jan, 2025.
- The selection of the applicants will be done purely on merit basis. There will be no reservation and weightage for this SPOT-II admission round. However, for 2 years B.Ed. /M.Ed. Courses, stream of the applicants should be followed strictly as they have appeared in the entrance examination.
- In this SPOT-II admission round, for all the aforementioned Courses, applicants can apply for up to three (3) options (HEI + Subject). In this round, applicants are allowed to apply for the subjects with no current vacancies, anticipating that seats might become available if an admitted student opts for CLC within the final admission date. However, selection will be done as per the seats available.
- Applicants participating in this SPOT-II admission round must physically report to their chosen HEIs with the required documents by 02.00 PM of 27.12.2024. Those who fail to report within the given timeframe will not be allowed to participate. In the applicant's absence, parents or guardians with due authorization may also report on their behalf with the necessary documents.
- As per the timeline, the rank-wise merit list of the applicants will be made available in the HEI's e-Space.
- Further, the HEIs will prepare the merit list among the reported applicants and publish the same on their Notice Board on the last day i.e. 27.12.2024. The selected applicants will be informed by the HEIs to validate their documents and pay the full admission fees directly at the respective HEI in online mode.
- The HEIs are requested to fill up the remaining vacant seats by calling the reported applicants rank wise till the last date of admission updation.
- After completion of this SPOT-II admission process, if seats remain available for the 2 year P.G. courses only, the Universities may fill the vacant seats by conducting a separate entrance examination at their level for the NON-CPET applicants.
- The timeline for all the aforementioned courses are as mentioned below.
