**ADVERTISEMENT FOR APPOINTMENT OF
VICE-CHANCELLOR OF ODIA UNIVERSITY, SATYABADI, PURI, ODISHA**

Applications are invited from eligible candidates below **62** years of age (as on **31st August, 2025, i.e. born after 01.09.1963**) for the position of Vice-Chancellor of Odia University, Satyabadi, Puri, Odisha. The applicant should be a distinguished academician of proven academic and administrative excellence and a well-rounded personality with a minimum of 10 years of experience as Professor in a University system or 10 years of experience in an equivalent position in reputed research and / or academic organization.

The post carries a fixed pay of Rs. 2,10,000/- (Rupees two lakhs and ten thousand) with Special Allowance of Rs. 11,250/- per month and other usual allowances such as Dearness Allowance. Provision of pay protection is applicable for candidates belonging to Central or State Government Public University or Institution. The tenure of the Vice-Chancellor will be three years from the date he/she assumes office or till he/she attains 65 years of age; whichever is earlier.

The applicants are required to apply in the prescribed application proforma through e-Mail (only in .pdf format) to our e-Mail ID (hedsec.od@nic.in) mentioning "Application for the post of Vice-Chancellor of Odia University" as the subject of the e-Mail.
