Sub: Special Relaxation for Submission of Final Graduation Mark Sheet/ Provisional Certificate for Admission into 2-Year B.Ed., B.H.Ed. & M.Ed. Courses under SAMS for the Academic Session 2025-26

Ref: This Department Letter No. 40729 dated 31.07.2025

Madam/ Sir,

In inviting a reference to the subject cited above, I am directed to inform you that the Phase-I admission into 2-Year B.Ed., B.H.Ed., and M.Ed. courses under SAMS will be conducted as per the instructions mentioned in the referenced letter.

However, it has come to the notice of the Government that in certain Universities of Odisha, including Odisha State Open University, Sambalpur, the graduation examination results of current-year pass-out students, which are essential eligibility criteria for admission into 2-Year B.Ed. courses have not yet been declared.

In view of this, this Department has decided to allow a **special relaxation** for applicants whose results are pending or whose provisional certificates/mark sheets have not yet been issued by their respective universities in Odisha. Such applicants shall be permitted to provisionally take admission, subject to the condition that:

- They must submit their final mark sheet/provisional certificate to the concerned Higher Education Institution (HEI) **on or before 04.09.2025.**
- Failure to submit the required documents in compliance to the Information Brochure within the stipulated date, or if the student is subsequently found to have failed or has a back paper or shortfall in required % of marks in the graduation examination, **will result in automatic cancellation** of admission by the concerned HEI on **06.09.2025**, without any further notice.

In the interim, during the document verification process, such applicants must submit:

1. Any available proof of their current admission/enrollment in the graduation course (e.g., admit card, university ID card, result awaiting certificate, etc.),
2. Photocopies of available documents as per Intimation Letter marked as "Submitted by me", duly signed by the applicant, and
3. The original documents (for verification), along with an **undertaking** declaring that the final certificate/mark sheet will be submitted by **04.09.2025**, failing which the admission will be forfeited.

This relaxation is being extended purely as a one-time measure for the current academic session: 2025-26, and all concerned HEIs are requested to ensure the guidelines.
