Superintending Engineer Rural Works Division, Kendrapara on behalf of Governor of Odisha invites Percentage rate bids through e-procurement for following **Building** works for the year 2025-26 as per Annexure. The bid should be submitted through on-line in the website www.tendersorissa.gov.in by eligible class of contractors of Government of Odisha of equivalent class Registered with Central Government/ State Government / Railway / C.P.W.D / M.E.S. The bidders must possess compatible Digital Signature Certificate (DSC) of Class-II & Class-III as per Annexure. The registered Bidders of outside Odisha, can also participate in this process after necessary portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Govt. before award of the work.

1. Class of Contractor: : As per Column-6 of Annexure.
2. Time for Completion : As per Column-7 of Annexure.
3. E.M.D required : EMD amount noted against the work as per Annexure is to be remitted **ONLINE** as part of the bid of the amount as specified in column-4. Of the Annexure.
4. Cost of tender paper : Cost of tender paper is to be remitted **ONLINE** as specified in column-5 of the Annexure.
5. Mode of submission tender : Tender should be submitted online in www.tendersorissa.gov.in
6. Period of availability of tenders on line / Date of time of bidding online / Date of opening of tender papers. : The details are as follows.

7. Bid documents consisting of qualification information and eligibility criteria of bidders, plans, specifications, drawings & the schedule of quantities of the various classes of work is available in website www.tendersorissa.gov.in
8. The bid uploaded for the work which are valid shall remain open for acceptance in the Website for a period of ninety days from the last date of receipt of bids. If any Bidder / Tenderer withdraws his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall be forfeited.
9. Tenderers represented through power of attorney holder should ensure that the power of attorney is duly signed and identified through an affidavit from first class Magistrate containing the photograph of both the license holder and the person to whom the power of attorney is given or else the tender will be considered for rejection.
10. If the office happens to be closed due to subsequent declaration as holidays by Government of local authority on the date of opening as specified above, tenders will be opened on the immediate next working day at the same specified time and venue.
11. The successful tenderer should produce all the original documents at the time opening of tender for verification.
12. Govt of Odisha, Works Department has been pleased to fix the Additional Performance Security vide office Memorandum No.173 dt.03.01.2026. Additional Performance Security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under.

13. I. Where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.
- II. Where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11%, with the additional bid performance guarantee being 0.1%, and this additional performance guarantee percentage shall be applied on the bid price.
- III. Where the bid price is 20% or more below the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price, and this additional performance guarantee percentage shall be applied on the bid price.
- IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5%, or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
- V. The additional performance security shall be treated as part of the performance security.
- VI. Justification for abnormally low bid shall be scrutinized by the Departmental Technical committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may in such cases seek written clarifications from the Bidder, including detailed price analyses of its bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid / Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.
14. **Additional performance security should be in shape of Term Deposit Receipt pledged in favour of the Divisional Officer/ Bank Guarantee in favour of the Divisional Officer from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (By Email) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further proceeding for blacklisting shall be initiated against the bidder.**
15. **The contractor has to upload an Affidavit regarding correctness of the documents uploaded in the website.**
16. **Exemption of EMD**
To avail the exemption of EMD, the intending Engineering Contractor should get the no. & name of work recorded in the original registration certificate. He should produce an affidavit along with the tender paper to the effect that he has not availed the exemption of EMD for 3 (Three) works during current financial year along with photocopy of license. Similarly the S.C Contractor desires to avail price preference and EMD exemption shall have to produce the required affidavit claiming the same.
17. Security for the due fulfillment of a contract should be taken. The Security may be taken in shape of N.S.C/Post Office Time Deposit Account/ Kissan Vikas Patra/ Bank Guarantee in favour of the Divisional Officer from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar towards EMD/initial Security Deposit / any other Security Deposit from the contractor.
18. **Black listing of the contractor / bidder**
If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case, the L2 bidder if fulfils, other required criteria would be called for drawing agreement for execution of work subject to the condition that L2 Bidder negotiates at par with the rate quoted by the L1 bidder otherwise the tender will be cancelled.
19. The rates to be quoted by the contractor shall be excluding GST. The implementation of GST rules by the Government of Odisha is to be accepted by the bidder at any point of time.
20. If a single tender is received in response to this notice, then tender for such work will be cancelled at first instance.

22. Subsequent Modification/ Corrigendum/ Addendum if required shall be appeared in the website only.
23. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.


